In the event that said costs are not paid, the Township may specially assess such costs against the subject property and/or take necessary legal action to recover such costs, including attorney's fees. Any amounts not utilized from this escrow fund shall be returned to the applicant, without interest, when all work has been completed, and all financial obligations to the Township have been satisfied. **It is the responsibility of the applicant to contact the Township upon completion of project to initiate the refund of any remaining escrow.**
